- 1) Recruiting and managing field volunteers. Midwives and physicians travel from the US to the project on a regular basis. Not only do they teach medical skills, they verify the integrity and funding of daily operations.
- 2) The executive director travels to the project site annually. When doing reviews of financial information, she matches original documents to verify the digital scans and electronic documents that have been used during the year, on an ongoing basis, as substantiation of expenses. The grantee undergoes a local annual independent audit, and that report is reviewed annually by the executive director.
- 3) The grantee's expenditures, bank reconciliations, income statements and other relevant documentation are reviewed electronically monthly, as are clinical outcomes. Clinical outcomes, verified by clinical volunteers, verify patient flows and costs of providing care.
- 4) Performing due diligence work related to 501(c)(3) equivalency status for grantees as well as monitoring terrorist watch lists.
